

How to take care of CV2S2000

Cleaning the CV2S2000

To clean the CV2S2000 device, it is recommended to disconnect the professional two-solenoid applicator from the device before carrying out any operation. Clean the fabric with a cloth dampened with simple water and neutral soap and wait for it to dry completely before reusing the two-solenoid applicator for a therapy session.
